## Privacy Notice

At BWB Partners P/S (“BWB”) we are committed to protecting your privacy and maintaining the security and confidentiality of your personal information. This Privacy Notice describes how information about you is collected, used, and disclosed by BWB if you for example apply for a position at BWB, if you are an investor, if you have a commercial relationship with BWB or if you otherwise interact with BWB and have given consent to the processing of your personal data (collectively, the “Services”) in accordance with the General Data Protection, the Danish Data Protection Act and related laws (collectively “The applicable laws”).

### 2. Collection of personal data

BWB may collect personal data when you access our services. Primarily we collect personal data if you are an investor in a BWB fund where we might process your name, title, and contact details according to GDPR art. 6(1)(b).

BWB stores your personal data as long as it is necessary to fulfil the purpose for which your personal data was collected and as long as it is consistent with the applicable laws.

All personal data is treated confidentially and BWB does not sell or pass on the personal data to others without consent.

BWB is obligated to file reports to detect, prevent, and investigate financial crimes in accordance with applicable KYC/AML procedures. To comply with this BWB will process both ordinary personal data such as name, title, photo, and contact details and special purpose personal data such as a copy of your passport.

### 3. Retention period of personal data

BWB will delete personal data regarding you when you request this or when it is no longer relevant to store. Special purpose personal data is deleted after two years at the latest. BWB conducts an annual review and subsequent clean-up where irrelevant personal data is deleted.

#### 4. International transfers

BWB may disclose your personal data to data controllers which involve the transfer of your data outside the EU/EEA. However, BWB will only transfer personal data if we are ensured an adequate level of data protection. This requires:

- The non-EU/EEA country has Data Protection laws similar to the laws in the European Union;
- BWB has obtained consent from the data subject to the transfer;
- If the recipient is based in the USA, the recipient must be a part of the Privacy Shield.

#### 5. Data security

BWB has implemented security measures to prevent your personal data from; being used or accessed in an unauthorized way; from being accidentally lost; or from being altered. This is ensured by restricting access to only include the employees who have a purpose accessing your personal data.

#### 6. Rights of Data subjects

BWB is fully aware of your data protection rights. As a data subject you are entitled to the following:

- The right to request BWB for copies of your personal data.
- The right to request that BWB correct any inaccurate personal data.
- The right to request that BWB erase your personal data, under certain conditions.
- The right to request that BWB restrict the processing of your personal data, under certain conditions.
- The right to object to BWB's processing of your personal data, under certain conditions.
- The right to request that BWB transfers the data we have collected to another organization, or directly to you, under certain conditions

#### 7. Complaints regarding data processing
